# **How an HSA works with UHC Rewards**




Every dollar you earn with UHC Rewards can be put into an Optum Bank HSA

# **Answers to frequently asked questions**

## If I have an HSA through a different bank do I need to create an Optum Bank HSA?

Yes. To redeem your earnings through UHC Rewards you will need to have an Optum Bank HSA.

**Note:** You will need to monitor your total annual HSA contributions to not exceed the IRS annual max contribution. This includes all contributions from UHC Rewards, your employer or yourself.

## Will I have to pay any fees to set up an Optum Bank HSA?

No, you will not have to pay any enrollment or maintenance fees when setting up your Optum Bank HSA.

#### How do I create an Optum Bank HSA?

After you've earned at least \$5 and you're ready to redeem your earnings for the first time, you can create your Optum Bank HSA. To do that:

- 1. Open the UnitedHealthcare® app and select UHC Rewards > Redeem Rewards > Optum Bank HSA.
- 2. Select Get an Optum Bank HSA and follow the prompts on the screen to create your account. Some fields are pre-populated.
- 3. After your account is created, enter the dollar amount you'd like to redeem and select Redeem rewards.

**Note:** It may take up to 3–5 days before your account is ready. Please allow 14 business days for any future deposits to appear in your account balance.

#### How do I access my Optum Bank HSA?

When your account is ready you can access your balance on the **myuhc.com**® homepage under **My account and spending** or from the UnitedHealthcare app on the home tab under **Rewards & Spending**.

### Can my spouse contribute reward dollars to an Optum Bank HSA?

You and your covered spouse can both activate UHC Rewards and deposit earnings into a single Optum Bank HSA. As the health plan subscriber, the Optum Bank HSA will need to be created in your name.
